6) Playing Field

- a) Image asking for final payment but PC not passed as so many issues to resolve. KM to write snagging letter and list and for Image to confirm all would be done. Interim payment to be considered if they start to complete.
- b) Look into getting a separate Rospa inspection before final payment and check the football goals for conformity.
- c) One resident asked whether picnic tables could be moved, and also reported that teenagers were using the park in the late evenings.
- d) Other residents asked for the climbing wall to be moved and for adjustments to the zipwire which was noisy.
- e) Need signs to discourage "peeing" in hedge backs and to indicate "curfew" times.
- f) Play Park Committee want to encourage "friending" of the Park to try and get more residents involved; idea of "Green Champions" to help look after the planting, and "Young Champions" to reduce antisocial behaviour and promote "ownership"
- g) New litter bins to be ordered estimated cost £640 for 2 serviced bins. Clerk to investigate.
- h) Play Park Opening Day scheduled for 9th September, with official opening to be carried out by Rishi Sunak MP. Event to feature a picnic, sports day, art competition, fancy dress competition and pub guiz.
